2. COMPOSITION / INFORMATION ON INGREDIENTS

Contains: A water based dispersion of surfactants and fine fillers

This product is not classified as hazardous according to current CHIP legislation

3. HAZARDS IDENTIFICATION

Main hazards: No significant hazard.

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be mild irritation at the site of contact.
