2. COMPOSITION / INFORMATION ON INGREDIENTS

Contains: Less than 0.1% w/w formaldehyde.

3. HAZARDS IDENTIFICATION

Main hazards: No significant hazard.

Other hazards: Formaldehyde, when in contact with skin, may cause dermatitis in sensitive persons.

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: There may be mild irritation at the site of contact.

Eye contact: There may be irritation and redness.

Ingestion: There may be irritation of the throat.

Inhalation: There may be irritation of the throat with a feeling of tightness in the chest.

4. FIRST AID MEASURES (ACTION)

Skin contact: Wash immediately with plenty of soap and water.

7. HANDLING AND STORAGE

Storage conditions: Store in cool, well ventilated area. Store in original containers between +5 and +25°C. Storage outside these parameters will dramatically reduce shelf life and invalidates all product warranties.

Suitable packaging: Must only be kept in original packaging.
